With various holidays in the Far East and Europe, it has been relatively quiet in terms of reported business previous week. In the Container Market, it has been reported that Kyokuyo Shipyard have received an order for two firm 1,100 TEU Container Carriers from Kotoku Kaiun. The duo is set for delivery in November 2017 and February 2018 from Shimonoseki. With this order, the Japanese yard will have 12 vessels on order with the majority for smaller LPG Carriers. There have been no orders in other sectors to report.
