The BDI continue to disappoint, fluctuating at the low 600's for one more week. We have recorded a total of 12 transactions (2 capes, 3 panamaxes, 2 ultramaxes, 2 supramaxes and 3 handysizes).

Demolition: Subcontinent market outlook is negative as demo-rates have decreased by almost \$50 dollars per lt the past 2 weeks.
