NEWBUILDING

In Gas, Nippon Yusen Kaisha (NYK) are reported to have placed an order for two firm 83,000 CBM VLGC at Japan Marine United (JMU). Although pricing was not disclosed these vessels are understood to deliver in 1Q 2019 from JMU's Tsu facilities. No additional conventional orders to report this week, however Flensburger SB have announced an order for four firm 4,100 LM ROROs from Siem Industries. Two units will be delivered in May and September 2017 and will be chartered out to DFDS A/S. The other two units are set for delivery throughout 2017 and 2018 from the German yard and is backed by a long-term charter to Alternative Tasimacilik A.S.. Astilleros Gondan in Spain have announced signing a contract with compatriot owner Naviera Nabia for one firm Passenger / Catamaran Vessel for delivery within 2017. The vessel will have a range up to 750 miles, a length of 24 meters and 8 meters breadth and will be able to accommodate 250 passengers at a maximum speed of 20 knots.
