NEWBUILDING

In Tankers, there are several orders to report for previous week. DSME have signed contracts with Clients of Maran Tankers Management for two firm plus two optional 318,000 DWT VLCCs. The firm two units are set for delivery in 1H 2018. Sungdong have also announced an order during Posidonia for two firm plus two optional 74,500 DWT LR1 Tankers with Clients of Tsakos Energy Navigation (TEN) for delivery in 1H 2018 for the firm vessels. HHI have won another order from Arab Maritime Petroleum Transport Co. (AMPTC) for a further two 158,000 DWT coated Suezmax for delivery in 2018 from the yard's Samho facility. These will be the 5th and 6th vessels in the series, following their last order in March this year. Batamec Shipyard in Indonesia have announced an order for one firm 6,500 DWT Product Tanker for an unknown Indonesian state-owned owner. This single unit will deliver in 2Q 2018.

The Gas market has seen a single order this week. DSME announced that they have signed contracts with Clients of Maran Gas Maritime for two firm plus two optional 173,400 CBM LNG Carriers. The firm two units will deliver within 2019 from DSME's Okpo yard.

In the container market, Jinling Shipyard have announced receiving an order from compatriot owner Shanghai Zhoggu Xinliang Shipping for four firm plus two optional costal trading 2,500 TEU Container Carriers. The four firm vessels are set to be delivered within 2018.

In other sectors, Uljanik Brodogradiliste have won an order from JSC KTZ Express in Kazakhstan for one firm plus one optional 5,250 DWT ROROs. The firm unit will deliver in end 2017 and the optional unit will deliver within 2018, if declared. Being 155 meters long and 17.5 meters wide, these vessels will be able to load around 54 rail carriages. Finally, Fujian Mawei have announced an order for one 6,200 DWT Asphalt & Bitumen Carrier from an unknown owner for delivery in 2018.
