### **NEWBUILDING**

In Tankers, Wisdom Marine have announced placing an order for two firm 115,000 DWT Aftramax Tankers at Japan Marine United Corporation (JMU). The duo will deliver in early 2019 from JMU's Kure yard in Hiroshima, Japan. It is understood that Fukuoka Shipbuilding have received an order for two firm plus two optional 19,900 IMO-II Stainless Steel Chemical Tankers from Stream Tankers AS in Norway. The firm two units are set for delivery throughout end 2018 and early 2019 and the optional two units will be delivered within 2019, if declared.

No additional conventional orders to report previous week, however BigLift Shipping BV have announced an order for one 9,900 DWT Heavy Lift Cargo Vessel at Zhejiang Ouhua. Delivering in 1Q 2018, the vessel will be fitted with 2 x 900t cranes and will be built to Ice Class 1A. Finally, Shandong Huanghai are reported to have won an order from Lianyungang C-K Ferry Co., Ltd. for one firm 35,000 GT Passenger / Car Ferry which can carry 1,080 passengers for delivery in 4Q 2017.
