A quiet week in the Newbuilding market with only one order to report. In the container market, Nippon Yusen Kaisha (NYK) Line are reported to have placed an order at compatriot shipyard Japan Maritime United Corporation (JMU) by declaring an option for five 14,000 TEU Container Carriers. It is understood that the deliveries for these five vessels are set throughout 2018 and 2019 from JMU's Kure facilities. The Japanese liner company already had ten vessels on order at Kure, with two already having been delivered earlier this year.
