There is only one new order to report this week. In Tankers, Daewoo Shipbuilding & Marine Engineering (DSME) have announced an order for two firm 318,000 DWT VLCCs for BW Maritime. The two vessels are set for delivery within 2Q 2018 from DSME's Okpo facilities. This is the second VLCC order DSME have received this year, after signing contracts with Clients of Maran Tankers Management in June for two firm plus two optional 318,000 DWT VLCCs for delivery in 1H 2018.
