### NEWBUILDING

A quiet week in the Newbuilding market with only a couple of orders to report. In Tankers, Doora Logistics Co., Ltd. in Korea are reported to have placed an order at Kangnam Corporation for a single 4,500 DWT Product Tanker for delivery in early 2018. This would be the first tanker order for the Korean naval yard based in Busan.

In other sectors, Vard have announced an order for two firm 16,100 GT Ice Classed Cruise Ships from Hapag-Lloyd Cruises GmbH for delivery in 1Q & 4Q 2019. The hulls of the vessels are scheduled to be built at the yard's Tulcea facility in Romania and the vessels will be finished and delivered from Vard Langsten in Norway and will carry 240 passengers.
