NEWBUILDING

One newbuilding order to report in the Tanker market this week, with Wuhu Shipyard in China announcing an order for an unknown Chinese owner for one firm plus one optional 28,000 DWT Chemical Tanker. The firm vessel is set for delivery in 2018 and the optional vessel will also deliver within 2018, if declared.

In Dry, Wisdom Marine Group have announced signing a contract with Imabari Shipbuilding for two firm 63,000 DWT Ultramax Bulk Carriers. Both vessels are due for delivery in 2019. Wisdom Marine also have two 81,000 DWT Kamsarmax Bulk Carriers and one 37,600 DWT Handysize Bulk Carrier on order at the yard.

In the container market, Jiangsu New YZJ have received an order for three firm 1,900 TEU Container Carriers from Jiangsu Ocean Shipping Co., Ltd. (JOSCO). The first vessel is set to delivery within 2017 and the rest of the two vessels will be delivered within 1Q 2018.

Finally in other sectors, Nisa Navegacion S.A. are reported to have placed an order at Asenav in Chile for one 3,000 GT Passenger/Cruise Vessel. This single unit (to be operated by Cruceros Australis) will have capacity for 210 passengers and is due for delivery in 4Q 2017.
