NEWBUILDING

There is only one order to report in the newbuilding market for this week. Shin Nihonkai Ferry have announced an order for one firm 14,400 GT Passenger / Car Ferry at Mitsubishi Heavy Industries. Being the 2nd vessel in series, this single unit is set to be delivered in within 1H 2017 from the Yard's Shimonoseki facility and will be able to carry 600 passengers / 22 vehicles. Shin Nihonkai Ferry had already ordered one vessel in November last year for delivery in 1Q 2017.
