NEWBUILDING

There is one order to report for previous week in the Container market. It came to light this week that Tropical Shipping have extended their order at Huangpu Wenchong shipyard in China by declaring an option for one 1,100 TEU Container Carrier. Delivering in 2018, this single unit will be the 4th vessel in the series.

In other sectors, South Korea's Dae Sun Shipbuilding have received an order from Hanil Express Co., Ltd for one firm 20,000 GT Passenger / Car Ferry for delivery within 2018. The vessel will be able to carry 1,200 passengers and 150 cars, and will sail in the coastal areas in South Korea between Wando, Yeosu and Jeju. From Japan, it has been reported that Imabari have signed a contract for two firm 15,000 GT Passenger / Car Ferries for delivery in 3Q 2018.
