It came to light previous week that Hyundai Mipo Dockyard have secured an order from Schulte Group (Bernhard Schulte) for one firm plus one optional 7,500 CBM LNG Bunkering Tanker. Delivery is due within the second half of 2018. In the RoPax market Fujian Funing Shipbuilding in China are reported to have signed a contract for two firm 7,152 GT Passenger / Car Ferries with an unknown Indonesian owner for delivery in 2018. With this order, Fujian Funing will have 11 vessels on their orderbook including four more Passenger / Car Ferries.
