NEW BUILDING

In Tankers, although contracted before the end of last year, it has been reported this week that Clients of Pleiades Shipping Agents have placed an order for two firm plus two optional 50,000 DWT MR Tankers at Hyundai Mipo Dockyard. The two firm units will deliver in 1H 2018 and the optional two units would be delivered within 2018, if declared. Asahi Tanker have extended their series at Minami Nippon by declaring an option for one 51,000 DWT MR Tanker. This will be the 3rd vessel in the series and is set for delivery within 2019.

In other sectors, VARD have announced receiving an order from Torghatten Nord AS for two firm 6,850 GT Passenger / Car Ferries for delivery in 2H 2018. The vessels will be able to carry 550 passengers and 180 cars and will be built to be LNG fuelled.

RECYCLING

Not again!

The New Year optimism has been quickly wiped away previous week with the sad news that there has been another fire on board the same LPG Tanker that caught alight back in December and now sadly, five more workers have lost their lives in this latest tragedy. This is now an alarming situation in Pakistan with this being the 3rd disaster in as many months. The reaction from the Pakistani Government was imminent - all ships arriving for recycling in Pakistan are allowed to beach but cutting/dismantling has been banned for 15 days. Following this closure, some uncertainty returned to the market but it will now be a case of how Bangladesh and India react and whether they take advantage of the current situation in Pakistan by attempting to reduce their rates in the knowledge they have one less competitor to contend with.

It appears there is a sense of a false market at present as one or two Cash Buyers seem to have a strong intention of ensuring the market is kept up for various reasons only known to them. The capsize bulkers in the market are attracting firm numbers, yet reports then suggest a Cape has recently been re-sold by cash buyers into Bangladesh to the breaker for region 325.00 per ldt. This seems the more realistic after demand locally in Bangladesh has suffered with yards reportedly close to being full and local steel plate prices declining. This disparity in prices show that the market is very difficult to mediate at present for all concerned and will be interesting to see at what rates these current sales are eventually re-sold to the breakers. It is felt a more cautious approach may be adopted next week on the back of a declining steel market but an increase in supply. We shall see...
