NEW BUILDING

Last week we saw the first order for Kamsarmax at a Korean managed facility for over 3 years (the last being Reuben Bros at Sungdong in 2014). Bahri have finalised an order for four firm circa 80,000dwt Kamsarmax with Hyundai, understood to be due for delivery from their Vinashin facility through 2020. In China, COSCO Dalian have secured an order for two firm plus one option 62,000dwt multi-purpose pulp carriers from COSCO Shipping Specialised Carriers, with delivery in 2019.

In the tanker market, it's reported that Sovcomflot have contracted an additional 42,000dwt Arc7 shuttle tanker at Samsung Heavy with delivery due in the last quarter of 2019. This follows three sisters which were delivered in the latter part of 2016.

RECYCLING

Temporary silence?

Plenty of signs of action but little to write home about at the end of the day!

With the Eid holidays now upon us, the momentum that had built over the past couple of weeks decreased last week as cash buyers and end recyclers retreat from the waterfront and partake in their festivities. This falls at a time just when the European holidays disperse and Owners return to their desks. This may see an increase supply of tonnage into the market on the back of the recent improvements in price indications as owners take stock of the current optimism. Generally, a much quieter week has been experienced which we feel is just a temporary lull. Market conditions have remained buoyant in all the mains recycling destinations and indications currently remain as of recent weeks.
