PACIFICCAPESIZE INDEX

The SSY Pacific Capesize Index climbed by 569 points to 5,948 points. The Pacific round-voyage rate (180k dwt) rose by \$2,000/day to \$23,500/day, while the Capesize iron ore spot rate from West Australia to China was up \$0.10/t to \$8.25/t.
