RECYCLING

Finally!

It has finally happened... following reports received, it is our understanding that there has been a breakthrough in Pakistan with news that the provincial government has finally signed off and consented to the lifting of the restrictions imposed for the importing of tankers into Pakistan for recycling. Whilst we are waiting to fully receive the full announcement, the gas free condition will, we are sure, be in line with India and Bangladesh and will only be allowed on a gas-free for hot work basis. At this time, we do not have the full details as the official notification will be circulated later this week, but there will most certainly be new stringent guidelines and regulations to be adhered to by Ship owners, Cash Buyers and recyclers alike. As aforementioned, the notification is expected to be circulated later this week and once formulated, we shall get the idea as to what new custom formalities will be required for tonnage arriving to the waterfront. Whilst this long awaited news is encouraging, it is stressed however that price levels are expected not to improve suddenly but will give a welcome reprieve for the Bangladesh market as it will ease the burden by once again opening up a viable alternative e for the larger tanker units that become available for a recycling sale. It seems cash buyers have been concentrating on resolving their previously purchased acquisitions with continued disputes on the waterfront in Bangladesh, but the slowdown in availability of new tonnage is allowing Buyers to finalise these transactions, albeit it is reported, at losses from their purchased levels.
