NEW BUILDING

A couple of new orders in LNG, firstly with Dalian Shipbuilding announcing an order from Xinao Energy Shipping for a single 8,500CBM LNG bunkering vessel for delivery in the middle of 2020. Samsung also announced the addition on one further LNG carrier – understood to be 174k – to a yet undisclosed buyer. Delivery of this unit is due at the beginning of 2021.

Only one order to report in the container sector this week, with Del Monte's shipping's division; Network Shipping, extending their series of fully reefer container vessels at CSSC Huangpu Wenchong Shipyard to six Vessels, after declaring a final pair or 634 forty foot reefer container Vessels for delivery at the end of 2020.

RECYCLING

Up in the Air!

It would appear that we have returned to the 'unknown' zone with plenty of vessels being talked into the market but a wide gulf in price indications and views amongst the relevant cash buyers.

Which direction the market will take is anyone's guess but surprisingly, and despite the large volume of tonnage said to be circulated, there remains a distinct lack of actual sales to report which may suggest expectations are currently higher from the Owners side. Generally, the domestic markets continue to have a stable feel to them but the uncertainty that set in last week remains in place, causing several Buyers to reconsider their next strategies.

Unfortunately, some reports of concern emanated from Pakistan this week adding to the apprehension. A fire took place on one of the tankers recently arrived at a local yard and subsequently, the local authorities imposed a seven day closure. It is understood no explosions or casualties occurred but on the back of this, many rumors began to circulate again that a longer ban could be imposed.

However, as always, these were purely rumors and we will know more next week, but the general consensus is that there will be some repercussions following this accident. But this seriously is the last thing these recyclers needed in light of the market only recently having opened officially for importing tanker units after such a lengthy spell on the sidelines.
