NEW BUILDING

In tankers this week, clients of Alpha (Pantheon) have signed contracts with SWS for two firm plus two option 115k Aframax for delivery in 2021. Otherwise the focus of ordering has been in the ropax/ferry market with a number of orders to report. Norled announced orders for two 299pax/80 car ferries at domestic yard Westcon for delivery in first half 2021 – the vessels will be hydrogen powered. Sunstone added the 7th vessel to their orderbook of cruise expedition vessels at China Merchants – the first in the series is due to deliver later this year. Barreras Shipyard in Spain announced the declaration by Ritz-Carlton of a second 300pax luxury cruise vessel with delivery due in 2021.

RECYCLING

For the first time this year, we are seeing the Indian market leading the way in the sub-continent as Prime Minister Modi's general election win brought some renewed confidence back to the market amid the quieter and rather sullen created by the Ramadan period. It would be expected that Containers and specialist Tanker units would receive stronger numbers at present compared to Bangladesh that has been swallowing the majority of tonnage for the year, although those in the market still expect any larger dry units, such as Capesize tonnage, to end up on the Chattogram shores due to their preference for these units and the final locations in the Far East.

Confidence from Bangladesh has certainly drained recently with the budget on 13th June making cash buyers and recyclers anxious as rumours that tax duties will be imposed which could in turn cripple rates on offer from the domestic recycling yards and steel mills. For any vessel available, and certainly units are scarce at this particular time, it will be difficult trying to obtain positive feedback and offers from Buyers until the budget has been announced.

Looking towards Pakistan, it still seems to be the same story where there is little demand locally, despite empty yards, after the currency devaluation at the start of the year and now with Eid upon us, the local recycling area must resemble something like a ghost town.
