Samsung are reported to have won an order from Mitsui & Co for one 50K product tanker, in a continuation of their series on order (now total 6) at the yard. This latest vessel expected to deliver in early 2021. In gas, KSS Line have announced they have contracted a pair of 84,000cbm Panamax beamed VLGCs with HHI. Both vessels will be scrubber fitted and will deliver in 1H 2021.

This may be one reason why we haven't seen Pakistan return to the market as many believed they would if prices fell below \$/400 ldt like they now have done for most vessel types and in particular Bulk carriers and Tankers.

With most Owners and key industry players enjoying their summer holidays and the start of the Muslim holiday Eid, there is a natural lull in the market, and it may be some time before any new and significant activity comes to fruition. Many predict that we will not see an upturn until mid-September, when its hoped the market will spring back into life.
