DSME announced further orders from clients of Maran Tankers with the addition of two 318,000dwt VLCCs for delivery in 3Q 2021. The yard also announced clients of Maran Gas contracting a single 174,000cbm LNG carrier for delivery in January 2022.

Just a single order to report in dry, with Mitsui OSK Lines ordering two 89,900dwt post-panamax bulk carriers at Oshima for delivery in 2022.

RECYCLING

Green India!

The encouraging news this week centres around India where the Government officially passed the 'Ship Recycling Bill 2019' which will prove to be a major turning point in the Shipping industry. In this respect, all recycling yards at Alang, W.C. India will have to be Hong Kong Convention compliant which will dramatically help the industry and offer positive environmentally friendly outlets to ship Owners.

It has taken a decade of hard toil, effort and financial outlay from the Indian ship recyclers to reach their goal and so huge congratulations to all those that have been involved in their restructuring towards better labour practices and environmentally friendly recycling facilities.

Meantime, this week has seen a continued trickle of tonnage into the market, some finally being sold for recycling, but still many older units finding trading buyers willing to table price levels slightly excess of scrap rates.

There has been a stable market across the recycling destinations which is resulting in more demand for units, albeit at no real big increase in rates.
