## **NEW BUILDING**

Tsuneishi Cebu are understood to have contracted four 42,000dwt Handymaxes with an as yet to be confirmed Japanese buyer, with delivery due from the latter part of 2021.

It has also been reported that Eastern Pacific Shipping (EPS) have contracted two firm plus two optional 50,000dwt MRs at Daesun – also for delivery in the second half of 2021.

#### RECYCLING

#### Stop, Start!

Having benefitted from an enthusiastic and active market over the last couple months, February has certainly seen a change in mood and optimism and following the recent decline in rates and sentiment, Buyers appear to be taking stock of their assets acquired and wait to see the next direction of the market.

However, there have been a number of varied units sold this week showing the difference in sentiment between India and Bangladesh, with the India market remaining steady and concluding the majority of available tonnage at impressive numbers. With its neighbouring Bangladesh continuing to wane, after impressively swallowing the majority of the 14 large dry units sold so far this year, it may take some time for these recyclers to digest their previous acquisitions before returning to the market in an aggressive manner. This leaves us to finally comment on Pakistan which has been in a subdued state for almost two years now, as the local recyclers have lacked any confidence to compete on market tonnage. The ship recycling market really needs this area to emerge again from the doldrums and start to become the force is once was if there is to be sufficient capacity for the predicted deluge of larger dry tonnage that will be seen this year.
