NEW BUILDING

Norden have announced adding a further two 61k Ultramax to their orderbook at NACKS making a series of six vessels, with the latest additions also due for delivery in 2022. Whilst understood to have been finalised last month, Marine Cove have ordered two 82k Kamsarmax at Sanfu, due for delivery in mid 2022.

Lastly, Hyundai Heavy announced orders from Korea Line (for Shell) for two firm 174,000cbm LNG carriers for delivery towards the end of 2023.
