



The SSY Pacific Capesize Index climbed by 403 points week-on-week to 4,558. There was a \$0.40/t increase in the W.Australia-China iron ore spot voyage rate to \$6.95/t while the round-voyage rate rose by \$1,500/day to \$14,750/day.
