



After two consecutive weeks of decline, the SSY Pacific Capesize Index climbed by 1,070 points to 7,628. There was a \$1.80/t increase in the W.Australia-China iron ore spot voyage rate to \$11.45/t while the round-voyage rate rose by \$8,100/day to \$30,000/day.
