

## **PACIFIC**CAPESIZE INDEX

The SSY Pacific Capesize Index fell 2,354 points over the past week to 9,414. The W.Australia-China iron ore spot voyage rate decreased by \$3.25/t to \$11.75/t, while the round voyage rate dropped \$17,500/day to \$19,250/day.
